Preparation: Building on Clean, Reliable Foundations

- Updating SU24 before role build begins

This ensures that roles are built on predictable, auditable logic—reducing the need for post-build corrections.

STUSOBTRACE: Real Usage, Real Insight

Running STUSOBTRACE in the weeks leading up to the project provides invaluable data:

- Captures real-time authorisation checks
- Highlights missing or redundant SU24 entries
- Reveals transaction-object relationships that are often overlooked

This trace data becomes the foundation for SU24 updates and role logic refinement. It's the difference between designing with clarity versus designing in the dark.
